Here we are again at the start of a new season for salmon. We have to be optimistic and believe it will be a good year, but then are not salmon anglers always optimistic, how else could we continue?

Ribble Fish Returns 2019

As you all know David Hinks collects and collates all the returns from clubs. In 2018 we caught 440 salmon with a catch and release of 96.36%, bear in mind that we basically get no returns below the Tickle Trout.

2019 was a very different year in that we had water, lots of it, and it for once favoured the Middle to Upper Ribble clubs. The problem here is that these clubs do not fish as much or have as many members as some of the clubs lower down. The water was often not of a good standard so some clubs you would have thought would have done well did not.

Given the data used to determine fish stocks it has been decided that we should encourage all clubs seek a return of all salmon, sea trout, trout and grayling that are caught and whether they have been killed.

However, with quite a few clubs to go we are hopeful of getting approximately the same number of fish. Most clubs reported good trout catches but not sea trout, again water was the problem. Pollution

We had a really good eight weekly meeting with the E.A. on Feb 6th. All the issues surrounding pollution, particularly reporting, were discussed. They gave us the structure and how it worked. Basically, Lancashire has 8 officers maximum at any one time. These officers are part of the Land and Water team and apart from pollution have a wide-ranging brief and it is this that limits the amount of time which can be given to pollution. It is crucial that the hot line is used to report any incident **0800 80 70 60** and not any individual officer. Put bluntly if it is not reported this way it does not exist. We have before explained the various categories that the E.A. classifies incidents and normally they will only attend most serious i.e. Fish kills.

However, information on serial offenders is counted up and can be taken into account when looking at a particular case. There is one such case in the pipeline at the moment.

When an incident is encountered/seen you report it **immediately** on the hotline ensuring that you **get, and note, a ref number and also, ask for feedback.** It is no longer the case that the operator will ask if you want feedback.

When you have this then contact the RFCA Pollution co-ordinators Fred Higham, Ribble and Hodder on **01200423314** and Graham Parkes on **07861 696813**. It is much better that the report comes from an eyewitness rather than one of our officers days later. Also, try and get photographs preferably dated, of the problem. The other important thing is to be able to identify where you are for the E.A. hotline operator because they will not know the area. There are apps you can have on your mobile phone which will do this for you.

Anti-Poaching

The above procedure applies equally for anti-poaching. The only difference is that the RFCA Anti-Poaching Officer is Grant Hinks and he can be contacted on **07930 807 980**. Grant is also a Angling Trust VBS Co-ordinator for the Ribble Catchment and takes part in joint patrols with the E.A. and Police.

RFCA Officer Changes.

E.A. Meeting

I mentioned above that we had a good meeting with the E.A. which covered Pollution and Poaching. Pollution cases being considered at the moment are Langcliffe Mill, Settle, Clitheroe Housing Development, Gisburn Dairy, Slaidburn Dairy Farm, Arla Dairy.

There are 3 Poaching cases in the pipeline at the moment. Damian Linney, Fisheries Officer liaises with the Police on a Regional basis,

Cheshire Police have the lead at the moment for environmental and rural crime and have established a dedicated team rural crime team.

Natural England have funding for 3 Enforcement Officers nationally. These will deal with problems on SACs and SSSIs. There is also a lot happening around elver enforcement.

E.A. Catch Returns - As you all know these are crucial in determining the classification of a river, Ribble currently classified as Probably at Risk (PAR). We discussed various issues here. The Stock Classification of rivers is a very difficult topic and is dealt with by the Regional Fisheries Council - NWATFCC - of which RFCA is a member.

Hodder - Gravels which have been a problem for many years may be nearing a solution! There has been a very positive meeting held with UU and the Hodder Consultative are hopeful of finally solving it. The use of the Hodder water bank was also discussed - This is very much a technical problem.

Locks Weir Cameras - I am delighted to say that the end may be in sight?

Long Preston, Red Scar Weir, Winckley Weir, Farming Rules were all discussed.

It was a very positive meeting and the E.A. are to be thanked at the resources they put in to servicing it, given their financial situation. We all believe that good relationships are essential if we are to do the best for the Ribble Catchment.

There will have to be a platform in the river to do some of the work but no time scale yet. There will also be a loss of mature trees in the Penwortham area which no one likes but there will be mitigation for this.
